Please submit the following documents for review.

- Proof of interest in Cheam Reserve land, e.g. copy of the lease, sub-lease. If the proposed premise is on *Certificate of Possession* land(s), then a declaration signed and dated by the CP-Holder(s) must be submitted with the application consenting to the cannabis business being conducted at the site by the applicant as based upon information set out in this application. If the lease agreement is conditional upon a *Cannabis Business Permit* approval and the application is deemed eligible, then an executed copy of the lease agreement must be submitted prior to the *Permit* being issued. The lease agreement must include use of the land for a cannabis business.
- A site plan of the premise – identifying perimeter of site, parking areas, locations of actual and proposed buildings, locations of actual and proposed fences and gates, setbacks from lot lines and environmental features, location and names of surrounding roadways, geographical directions.
- Business Plan – including a business overview, sales and marketing plan and financial plan for the cannabis business.
- Floor plan of the building(s) – including entrances/exits, walls, dimensions, point of sale area, office area, storage area(s), and shipping/receiving area. Each outdoor and indoor area must be named. All proposed cannabis-related activities conducted in each area must also be identified.
- Detailed description of physical and organizational security plans.

Part E – APPLICATION FEE

In accordance with the *Cheam Cannabis Control Law, Schedule 'A'*, a non-refundable application fee payable to the Cheam First Nation is required to be submitted with the application.
