Cheam Land Governance Advisory Committee CALL FOR MEMBERSHIP

Cheam First Nation is seeking committed Band Members willing to join the Cheam Land Governance Advisory Committee. As Cheam is under Land Code, we require input from membership on land law development and other matters that affect our Reserve Lands. The Committee has (4) seats, plus one (1) Councilor & one (1) staff member of which the term may expire in September 2025.

Role of the Cheam Land Governance Advisory Committee

The Cheam Land Committee was established under Section 6 of the Cheam First Nation Land Code.

Committee Established

The purpose of the Committee is to:

- (a) Advise Council and the Land Governance Director on the Cheam Reserve Land administration system;
- (b) Advise Council and Cheam staff on matters respecting Cheam Reserve Lands;
- (c) Recommend to Council Laws, Council Resolutions, policies and procedures respecting Cheam;
- (d) Subject to section 10 (Dispute Resolution), hold, or help arrange, meetings of Members and other meetings to discuss issues relating to Cheam Reserve Lands and make recommendations to Council on the resolution of such issues;
- (e) Assist in the exchange of information between Members and Council regarding Cheam Reserve Land matters;
- (f) Oversee other consultations under this Land Code and providing Council with updates; and
- (g) Perform such other duties and functions as Council may direct.

Eligibility

Any Eligible Voter, whether or not resident on Cheam Reserve Lands, is eligible to be appointed to the


- A member of the Committee will serve for two years or until that member: (a) Resigns in writing; (b) Becomes ineligible to be a Committee member; (c) Ceases to be an Eligible Voter; (d) Is removed by Council Resolution, including if this reaction the Committee the Committee (e.g., attending sessions under the influence), or if miss two (2) consecutive meetings without confirmation; or
 - (e) Dies or becomes mentally incompetent.

Individuals who are successful will be selected by Cheam Chief and Council to fill the four (4) seats with honorariums provided for according to the Terms of Reference and approved budget.

If you are a Cheam Band Member 18 years of age or older and interested in this opportunity, you are encouraged to submit a letter expressing your knowledge, experience and interest and any information that may help with selection. 





PROJECT UPDATES FROM COUNCIL

Longhouse Project Completion 2023

For the past two years, the Chief and Council, Longhouse Committee, and staff have worked to secure funding to support a 2,400 sq/ft addition to the Longhouse for a kitchen, washrooms and septic. On May 5, 2022 the Community was awarded funding through Canada Cultural Spaces for the project. Due to the rise in material costs, the size of the addition is now 2,400 sq/ft and the Chief and Council approved a motion to provide the additional funding to ensure project completion. Working with Station One Architects, the design process began, and once it was approved and the tendering process completed, Gerry Enns Contracting (GEC) was hired to build the Longhouse addition and septic field. The construction started on Monday, July 17, 2023 and is on schedule to be completed by December 31, 2023.









Updates on the Cheam Early Years Program and Education Portable

The Cheam Early Year Program opened in April 2023 and takes place in the Education Portable with approximately 15 children and youth attending daily.


Weekly activities are arranged to engage the children with cultural activities such as learning to paddle a canoe, Halq'eméylem lessons, singing and drumming, history, storytelling/book reading, regalia making, crafts, weaving, canning, beading, Coast Salish drawing, learning about traditional plants, and attending events such as Reclaiming Our



Youth Pow Wow at Saint Mary's, and Coastal Jams for Truth & Reconciliation with Cheam Elders honoring those that attended Residential Schools.

In addition to the programming, the children are also provided snacks, lunch and/or dinner and a snack bag at the end of the day.





Due to the age of the building, the Council allocated funding dollars to complete a kitchen and washroom renovation to make it more functional and safer for the children. This renovation is on schedule to be completed this week.

Some of the renovation improvements include:

- Updated kitchen with new appliances, cupboards, countertops, and flooring;
- Newly expanded washroom to allow for all abilities access;
- New storage;
- Children's coat rack, shoe rack and cupboard; and
- Exterior renovations that include the addition of a chain link fence, lattice, and new railings in both the front and back of the building and new stairs in the back of the building.

We are grateful for funding from the BC Aboriginal Child Care Society and BC Education and Child Care that allows us to put on this program and complete the necessary renovations.

My name is Samantha Narayan, I live on the unceded, ancestral lands of the Katzie, Kwantlen, Semiahmoo and other Coast Salish Peoples. I work for the First Nation's Health Authority as a Field Supervisor in the Fraser Salish Region for the upcoming Regional Health Survey Phase 4 (RHS4). I am reaching out in hopes that we can discuss your community's participation in RSH4.

The First Nations Health Authority would like to invite your First Nation to take part in Phase 4 of the BC First Nations Regional Health Survey (RHS 4). The RHS is a data collection project that seeks to gather useful health and wellness information for BC First Nations children, youth, and adults, in a way that follows principles of First Nations Ownership, Control, Access and Possession (OCAP®). Nationally, this initiative is overseen by the First Nations Information Governance Centre (FNIGC), with First Nations organizations in other provinces and territories participating.

Phase 4 is different in a few substantial ways. First, our data collection options have expanded to web surveys, telephone surveys, paper surveys, or in-person surveys (with COVID-19 safety plans). We would like to learn and to plan around which options may fit your community best. Second, we are inviting all BC First Nations communities to participate. Third, we have increased the range of our participant safety measures. Fourth, we are inviting about 14,000 First Nations individuals across BC. Fifth, because of that, we have more flexible options for data return (e.g., communities may agree to be part of a Nation or language family grouping).

To confirm your First Nations community's interest in participating, we will require either a signed **Community Participation Agreement or a signed Band Council Resolution.** Before that, we can discuss your community's data return options and preferred survey types. Each participant in your community will receive a gift card valued \$ 25. Find the attachments &

Our services include but not limited to:

Dentures over implants: Dentures supported by implants replace a full set of upper or lower teeth. They rely on implants to act as anchors, eliminating the need for adhesives. The dentures snap onto the implants, which hold them securely throughout the day, so you don't need to worry about them moving.

Complete and partial dentures: Replacing a full arch, or one or more missing teeth in the same arch. **Precision dentures**: We offer precision denture services. Our denturists will take in factors such as the shape of

your face, jawline, lips, eyes, eyeglasses and hair colour, and create a denture for you.

Suction dentures: These require specialised moulding techniques to design. Suction dentures rely on creating strong retention using atmospheric pressure.

Immediate dentures: An immediate denture is a complete or partial denture inserted on the same day, immediately following the removal of natural teeth.

Relines + Rebases: A process that adds material to part of the denture to improve the fit. It can also replace or repair parts of the dentures that may be causing a poor fit.

Repairs: Adding teeth to an existing partial denture after new extractions, or fixing broken dentures. **Nightguard**: Protects the teeth from damage by cushioning the effects of clenching while sleeping.

Toxic Drug Response & Priority Populations Overdose Outreach Team

What's Happening?

The Fraser Health (FH) Overdose Outreach Team (OOT) works in allyship with individuals accessing the unregulated toxic drug supply to reduce the risk of toxic drug poisoning. OOT works with individuals to enhance wellness, personal resilience, self-determination and build knowledge to support safer navigation of or separation from the increasingly toxic drug supply.

OOT acknowledges not everyone who uses substances or experiences a toxic drug-poisoning event has a substance use disorder that requires clinical substance use services.

When Will This Happen?

OOT is currently taking referrals. Please see below for referral process.

Important Things To Know About OOT?

- Individuals are not required to alter their substance use to access OOT services.
- OOT is a multidisciplinary team comprised of peer support workers, outreach, and nurses working alongside social workers and consulting with harm reduction coordinators.
- Target population: Anyone > 19 yrs., accessing the unregulated toxic drug supply and are at risk of toxic drug poisoning.
- **Referrals:** Anyone can refer to OOT and clients can self refer. Client consent for referral is required.

For Fraser Health sites that use PARIS:

Please refer by completing and submitting a referral through the 'Substance Use Referral Form' on PARIS. Select the OOT team for the region you are making the referral to, which is determined by the client's address (i.e. if you are making a referral for Fraser East, please select *PH Overdose Outreach Team East*).



First Nations Health Benefit Program

The First Nations Health Benefit (FNHB) Program covers specific medically necessary items, services, and travel that support First Nations peoples' health and wellness needs. The program is administered through partnerships with Pacific Blue Cross and PharmaCare.

Eligibility

The FNHB Program is available to First Nations people with Indian status who live in BC and infants (up to 24 months) of an eligible parent. To access the benefits and coverage under the Health Benefits Program, First Nations people must first enroll in the program. Please call 1-855-550-5454 or visit **fnha.ca/benefits/eligibility** for more information on how to enroll.

Health Benefits Coverage

The FNHB Program covers six benefit areas:



DENTAL

The Dental benefit provides coverage for items and services to maintain good oral health, prevent cavities, gum disease, and restore damaged tooth function. Some items and services covered under the dental benefit are bridges, crowns, exams and x-rays, fillings, and preventive services.



MEDICAL SUPPLIES AND EQUIPMENT

The Medical Supplies and Equipment (MS&E) benefit provides coverage for items and services needed in the short or long-term to support health and wellness. Some items and services covered under the MS&E benefit are bathing and toileting aids, hearing aids and repairs, limb and body orthotics, ostomy supplies, walking aids, and wheel-chairs.



MEDICAL TRANSPORTATION

The Medical Transportation (MT) benefit assists with the cost of meals, accommodation, and transportation towards travel for a medical appointment outside your community of residence. The MT benefit may also cover travel escorts under certain conditions.











MENTAL HEALTH

The Mental Health benefit covers in-person and virtual counselling services from a qualified mental health provider registered with the FNHB. Coverage is available for Mental Health counselling from four programs. The Mental Wellness and Counselling program is for Status First Nations individuals, while the Indian Day Schools Health Support Program, Indian Residential School Resolution Health Support Program, and Missing and Murdered Indigenous Women and Girls Health Support Services are available to both status and non-status individuals. Talk to your Mental Health Provider to determine the appropriate program for you.



PHARMACY

The Pharmacy benefit, administered mainly through Plan Wellness (Plan W), provides coverage for medications and items that support First Nations people on their wellness journeys. The Pharmacy benefit covers specific prescription drugs, over-the-counter drugs, non-drug over-the-counter items, and Shingrix® vaccine. Please call 1-855-550-5454 to enroll in Plan W.

In addition to Plan W, the provincial agencies, including the BC Cancer Agency, BC Transplant, BC Renal Agency, and the BC Centre for Excellence in HIV/AIDS, provide specialty pharmacy items to all BC residents living with specific illnesses or conditions.



VISION CARE

The Vision Care benefit provides coverage for items and services to ensure proper eye health and support access to preventative care. The benefit covers eye exams, sight tests, prescription eyewear and repairs.

OTHER COVERAGE

BC Medical Services Plan (MSP)

The FNHB manages MSP for First Nations people in BC. If you have status and need to register for MSP, call 1-855-550-5454.

Ambulance Bills

The FNHB covers the cost of ambulance transport to a hospital in an emergency situation and from a lower level care facility to a higher level care facility (e.g., long-term care home to a hospital).
