






**Note:** Multiple federal and provincial sources have funded the projects noted in this report.

The "Watershed and Wildlife" projects can be noted as proposal-driven grant funding and Tourism-related business projects assigned via the Chief and Council and Cheam Enterprise Inc. (CEI) Board of Directors.

Many of the noted projects have been and will be driven by CEI subsidiary Ayelstewx with the idea to have them housed in an A.R.&T Department once a plan is in place at Cheam First Nation (CFN).

Most of the "Watershed and Wildlife" project outcomes relate to the long-term desire of CFN to have a Natural Resources Department and AR&T Department. The project deliverables and activities have and will continue to utilize CEI business flows (JV, partnerships, member businesses and others).

CEI applied for the funds on behalf of Cheam First Nation. Currently, Cheam has responsibility for:

#### **Aquatic Habitat Restoration Program**

- 100k capacity funding update
  - **>** Foreshore capacity development
  - **>** Best practices for foreshore management
  - > Reporting deliverables are complete
  - > Reporting template is complete
- Phase 2 Hope Slough Restoration Project with Cheam First Nation, Skwah First Nation, and Shxwhá:y Village
  - ▶ 2.1 million projected administered by CFN and managed by CEI
  - ➤ Hope Slough Flow improvement (pond creation and restoration/sediment removal),
  - ➤ Water Quality testing (23 water testing sites tested monthly),

- Salmon spawning bed restoration (2 Chum spawning beds, 3 Chinook spawning beds and 2 Coho spawning beds)

Currently, CFN has assigned three special projects to the CEI Special Projects Lead. The first project is the Cheam Fishers Bank Stabilization Project, the second is the Backwash Re-connectivity Bridge Construction Project, and the third is the Cascade Skyline Gondola Corp.

#### **OVERVIEW**

On May 16th, 2022, the campground experienced a changeover in relation to the Park Operations Manager. Noelle and Ray Hartt, both former employees of Cheam First Nation, arrived in support of Cheam First Nation's vision for the development of the campground. Due to the unprecedented late freshet and above-average rainfall for the month of June, the campground experienced significant flooding issues and some damage.

The flooding impacted the lower riverside sites, upper field, and the main roadway in and out of the campground, as well as a partial loss of the group site embankment wall (riprap); the campground had a partial closure for (2) weeks and a full closure for (1) week. Unfortunately, the full closure spanned over one of the busiest long weekends of the season, Jul 1st. To attempt to mitigate the loss of revenue, the season was extended to Oct. 10th and was well received by guests. Despite this stressful time, we successfully navigated the challenges and demonstrated resilience.

Consistent operations, support, and professional development opportunities were offered to CFV staff. Maintenance Supervisor Dacian Victor and Maintenance Worker Wesley Edwards completed their First Aid Snow Removal Course (incl bobcat and mini excavator operations) in Nov. 2022.

Improved information on the standards of what guests can expect during their stay at CFV and clear guidelines and etiquette required from our registered campers was improved. The CFV team strived and promote a quiet, safe, family-oriented space for all visitors.

#### **OPERATIONS**

In November 2022, in preparation for the 2023 season, we implemented Camp Spot after researching several online reservation software. This online web-based reservation booking system offers guests the convenience of reserving online. This has greatly improved the booking process for those who live internationally and increased revenue around cancellation and pet fees. Payments and digital signatures, accepting the Terms & Conditions, also expedite the guest's check-in upon arrival, which guests have expressed is one of the key features they appreciate. Risks or significant issues – flooding (working with EMBC re: installing Tiger Dams & sandbags Wins include building rapport with our guests and having an amazing maintenance crew.
